

## **Privacy policy – POSSIBLE Germany Careers Website**

At POSSIBLE Germany we are committed to ensuring that your personal information is protected and never misused.

Our privacy policy explains what personal information we collect, why we collect it, how we use it, the controls you have over your personal information and the procedures that we have in place to protect your privacy. It applies to personal information we collect through our POSSIBLE Germany Careers Website and any associated applications for employment which come through the POSSIBLE Germany Careers Website.

By sharing your personal information with us, and by continuing to use our POSSIBLE Germany Careers Website, you confirm that you have read and understood the terms of this privacy policy. We take responsibility for the personal information we collect about you, and we aim to be transparent about how we handle it, and give you control over it.

In this privacy policy, when we refer to "POSSIBLE Germany", "WPP", "us", "we" or "our", we mean the WPP group company or companies which provide you with the WPP careers websites. In this policy, we refer to all WPP group companies as the "WPP Group".

### **What personal information do we collect?**

Our main reasons for collecting your personal information is to provide you with information or services that you have requested including supporting your applications to WPP and to provide and improve the service, products and experiences that you and the users of the WPP POSSIBLE Germany Careers Website, applicants and employees expect from us.

We collect personal information from you in several different ways; you may share that information with us, or we may collect it using other means. In this section, we explain the different ways we collect personal information from you and some ways in which that information will be used. For more detail on how we use your personal information, please see the section titled "How do we use your personal information?".

### **Information you share with us**

We collect personal information that you share with us when you register, contact us or interact with us through our website, email, phone or otherwise. You can decide not to provide certain information, or ask that any information you have previously shared is removed. If you do so, you may not be able to take full advantage of a career at WPP and progress an application.

For example, you may provide information to us when you contact us about an opportunity to work at WPP, upload a CV or Resume or other careers information.

To apply for a role listed on our website we require users to register and to provide us with basic contact information. Through these interactions you may share with us: your name, address, e-mail address, postal address, contact number, career history (usually in the form of a CV) as well as any other personally identifiable information you include in your interactions with WPP. We may also ask for additional information to assist us with our recruitment process and in the event you are offered a job.

## **Cookies**

We may use cookies and similar technologies to collect non-personally identifiable information from you and to customize your use of the careers website. A cookie is a small data file that certain web sites write to your hard drive when you visit them. We may also use web bugs, clear gifs and similar technologies that collect data similar to that collected by a cookie. A cookie file can contain various types of information, including a user ID that the site uses to track the pages you have visited.

Most browsers are initially set up to accept cookies; however, you can reset your browser to refuse all cookies or indicate when a cookie is being sent or you can flush your browser of cookies from time to time. (Note: you may need to consult the help area of your browser application for instructions.) If you choose to disable cookies or refuse to accept a cookie, you may not be able to utilize all features of the careers website.

Should you visit any of our WPP Group company websites, cookies may be used as described in the relevant privacy policy, so it is a good idea to check the privacy policies which govern those websites.

This website uses Google Analytics, a web analytics service provided by Google, Inc. ("Google"). Google Analytics uses "cookies", which are text files placed on your computer, to help the website analyze how users use the site. The information generated by the cookie about your use of the website (including your IP address) will be transmitted to and stored by Google on servers in the United States. Google will use this information for the purpose of evaluating your use of the website, compiling reports on website activity for website operators and providing other services relating to website activity and internet usage. Google may also transfer this information to third parties where required to do so by law, or where such third parties process the information on Google's behalf. Google will not associate your IP address with any other data held by Google. You may refuse the use of cookies by selecting the appropriate settings on your browser, however please note that if you do this you may not be able to use the full functionality of this website. By using this website, you consent to the processing of data about you by Google in the manner and for the purposes set out above.

## **How do we use your personal information?**

Our main reasons for using your personal information is to provide you with information or services that you have requested including supporting your applications to WPP and to provide and improve the service, products and experiences that you and the users of the WPP careers website, applicants and employees expect from us.

We may share your personal information with companies in the WPP Group, and given the global nature of our company, your personal information may be transferred from one jurisdiction to another. When we make such transfers, we do so in accordance with data protection legislation, for example by using Standard Contractual Clauses where information is transferred from WPP in the European Economic Area to WPP in the United States of America.

By submitting your personal information to us, you agree to us transferring, storing and handling your personal information in this way.

We share your personal information with certain third parties who provide services on our behalf. They only have access to the personal information they need to perform those services. They are required to keep your personal information confidential and may not use it other than as we ask them to and always in accordance with this privacy policy.

## **Information you share with us**

We use the personal information you share with us in the following ways:

- To respond to your queries and requests;

- To communicate with you;
- To provide you with updates about your WPP application;
- To provide services and support for any application you make;
- To facilitate any application you make to WPP;
- To provide updates to you about any changes to WPP's policies, terms and conditions and any other matters which we may need to tell you; and
- If you have asked us to keep you informed of other opportunities at WPP, we may periodically contact you to tell you about these for up to 6 months.

### **Contacting You in the Future**

If you have asked us to we will keep you informed of other opportunities at WPP for up to 6 months. We do this in various ways, including e-mail, post, SMS, via social media platforms and by phone, but only if you are happy for us to do so.

### **Links to third party websites**

We may provide links to other websites which are not operated and controlled by WPP.

We have no control over and are not responsible for the content of those sites or how the third parties responsible for them collect and use your personal information. We do not endorse or make any representations about third party websites.

Third party websites may have their own privacy policies explaining how they use and share your personal information. You should carefully review those privacy policies before you use these websites to make sure that you are happy with how your personal information is being collected and shared.

### **How long do we keep your personal information?**

We only keep your personal information for as long as we need to, to be able to use it for the reasons given in this privacy policy, and for as long as we are required to keep it by law. Following an application we keep your information should any other opportunities become available; however we will only keep your information for a limited period and your details will be purged after 6 months.

### **Informing us of Changes**

If any of the information that you have provided to WPP changes, for example if you change your e-mail address, name or postal address, you can update, amend or remove information by submitting a request to [mun.careers@possible.com](mailto:mun.careers@possible.com) .

You have the right to access, update and amend personal information that we hold about you. You can also ask us to remove personal information about you or limit its use.

If the law in your country allows us to impose a fee for giving you access, we will communicate this to you in response to your request.

### **How do we protect your personal information?**

We use appropriate technical and organisational measures, including encryption, to protect your personal information and privacy, and review those regularly. We protect your personal information using a combination of physical and IT security controls, including access controls that restrict and manage the way in which your personal information and data is processed, managed and handled. Whilst we cannot guarantee the security of your personal information, we commit to taking all reasonable steps to do so.
